Pursuant to Order No. 01 in Docket UE-130536, the Company is also filing Original Sheet 94, “BPA Transmission Revenue”, to refund to customers, during 2014, the entire 2013 and 2014 revenue associated with the Bonneville settlement agreement (approximately \$4.2 million). The 2013 and 2014 refund has been spread to all rate schedules in 2014, to offset the scheduled rate increase, using the same rate spread/rate design methodology as other transmission costs and revenues were allocated to customers in the Company’s last general rate case. Further, within each rate schedule the refund was applied to the volumetric blocks on a uniform cents per kWh basis, or on an energy basis.

The Settlement Agreement approved in Order No. 09/14 stated at Paragraph 6 that “Avista will include in its tariff transmittal letter a statement of the ERM balances existing at that time, by year, and the 2013 ERM balance to date”. As of August 31, 2013, the ERM balances by year, and 2013 ERM balance to date are as follows:


