## NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS ON THE SECOND DRAFT PURCHASES OF ELECTRICITY RULE (By 5 p.m. on September 14, 2020)

Re: In the Matter of Amending, Adopting, and Repealing WAC 480-107, Relating to Purchases of Electricity, Docket UE-190837

### TO ALL INTERESTED PERSONS:

On February 5, 2020, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) in Docket UE-190837 to update its purchases of electricity (PoE) rules in WAC 480-107.

Along with the CR-101, the Commission issued a Notice of Opportunity to File Written Comments for stakeholders to answer questions related to the Purchases of Electricity (PoE) chapter and reference rules. Those rules were developed in the prior rulemaking docket, UE-161024, and provided for reference in this docket, UE-190837. The Commission received comments from 11 stakeholders.

On June 1, 2020, the Commission issued its 1<sup>st</sup> draft PoE rules and received comments on those rules on June 29, 2020. The Commission held a workshop on July 16, 2020 to hear from interested persons and discuss the 1<sup>st</sup> draft PoE rule.

With this notice the Commission issues its 2<sup>nd</sup> draft PoE rules for comment and the Staff Comment Matrix with Staff's responses to comments received in this docket. In addition, the Commission requests that interested persons respond to the specific questions below.

## **ISSUE DISCUSSION**

The 2<sup>nd</sup> draft rules are structured differently than the 1<sup>st</sup> draft rules. The conditions under which a utility must issue a request for proposal (RFP) are stated in draft WAC 480-107-010, and the application of the rules to different RFPs are identified in draft WAC 480-107-011.

The 2<sup>nd</sup> draft rules expand the requirement to issue an RFP and place certain requirements on the RFP process and content. This reflects Staff's belief that RFPs are the best vehicle for discovering the lowest reasonable cost resources available in the market from a number of providers, including competitive independent power developers.

The 2<sup>nd</sup> draft rules limit the requirement for a utility to retain an IE to where the utility has a financial self-interest.

The 2<sup>nd</sup> draft rules include a definition of "repowering" to reflect the decisions a utility makes concerning resources it owns and requires that repowering utility-owned generation facilities to be evaluated in the utility's RFP with the use of an independent evaluator.

The Commission requests comments on both of these topics.

# **QUESTIONS FOR CONSIDERATION**

The Commission requests feedback on the entirety of the 2<sup>nd</sup> draft rules, but it specifically requests comments in response to the following questions. Stakeholders are encouraged to submit proposed edits to the draft rules as an attachment to their comments.

- 1. Draft rule WAC 480-107-007 defines repowering. Is the definition clear and do the rules succeed in assuring that a utility's decision to rebuild generation it owns is evaluated on an equal basis with other alternatives available in the market?
- 2. Draft rule WAC 480-107-010(1)(b) requires a utility to issue an RFP if "the utility's twoyear IRP update demonstrates a new or unfilled resource need of 80 MW compared to the utility's most recently filed IRP." Please provide comments on whether you support or oppose this provision and why?
