1 **PROCEEDINGS:** On September 4, 2003, the United States District Court, Western District of Washington at Tacoma, Judge Ronald B. Leighton presiding, entered its Stay Order and Order of Referral to WUTC [Washington Utilities and Transportation Commission], in Case No. C03-5012, a civil complaint proceeding styled *Washington Exchange Carrier Association, et al., Plaintiffs, v. LocalDial Corporation, an Oregon Corporation, Defendant*. The Commission entered Order No. 03 Prehearing Order Concerning Intervenor And Interested Person Status on November 14, 2003. Order No.03, among other things, identified 13 entities as interested persons (“IPs”).<sup>1</sup> Informal, follow-up correspondence to the undersigned presiding ALJ offered corrections.
