TO ALL PARTIES:

On April 15, 2005, Verizon filed “draft” pages of tariffs that under the terms of Order No. 16 would become effective on July 1, 2007. It represented that tariff pages that are identical in all material respects would be filed no later than June 1, 2007. The commission entered its Order No. 16 in this docket on April 29, 2005, and stated that pages that were identical in all material respects may be approved by letter of the Secretary if filed no later than June 1, 2007.
