
Description of amendment:

The Agreement is amended by removing terms, conditions and rates for Batch Hot cut as set forth in Attachment 1 to the Amendment.

The amendment amends the interconnection agreement first approved by the Commission on February 6, 2004 in WUTC Docket No. UT-033035 and accepted in Docket No. UT-043125.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
