Dear Mr. Johnson:

In compliance with Order 01 of Docket No. UE-160100, and Order 01 of Docket Nos. UE-170327 & UG-170328, Avista Corporation, dba Avista Utilities (Avista or “the Company”), hereby submits for electronic filing with the Commission its annual report on retired electric meters and natural gas meter Encoder Receiver Transmitters (“ERTS”) for the calendar year 2020. This report is intended to comply with the requirements outlined below:

Order 01 in Docket UE-160100:

- (2) Avista Corporation must file with the Commission an annual report by January 31 of each year, beginning January 31, 2017, documenting the actual number of meters retired in the previous calendar year and the net book value of those meters at the time of retirement.

Order 01 in Dockets UE-170327 and UG-170328:<sup>1</sup>

- (13) The Commission approved the Company’s request for like treatment of its natural gas communicating modules (Encoder Receiver Transmitters or ERTs), consistent with the treatment previously approved for retirement of the Company’s electric meters.

Throughout the 2020 calendar year, Avista continued its deployment of Advanced Metering Infrastructure (AMI) for its electric and natural gas customers in Washington. As the full-scale deployment of advanced electric meters and natural gas modules progressed throughout the year, the Company retired approximately 146,228 existing electric meters and 26,849 natural gas meter ERTs, for an associated total net book value of \$11,162,635.74 and \$1,449,123.17, respectively. Avista will continue to track these retirements and their values for the duration of its AMI deployment.
