The company offered to waive the March 1, 1993, suspension date to a date not later than the October 1, 1993, suspension date it expects to have in a general rate case the company expects to file in November 1992. Several parties expressed concerns regarding the interrelation between the two cases.

If the Commission determines the tentative schedule should be revised in view of the company's waiver of the suspension date, the Commission will advise the parties by separate letter.
