Dear Ms. Washburn:

Verizon Northwest Inc. ("Verizon NW") submits for filing Advice No. 3252, which provides changes to the General and Local Exchange Tariff, WN U-17, Section 5, related to the residential Late Payment Charge. Specifically, the purpose of this filing is to remove the December 31, 2007 expiration of the effectiveness of the residential Late Payment Charge from the tariff. As the commission noted in paragraph 3 of Order No. 17 in Docket No. UT-040788 (referring back to Order No. 15 in the same docket), Verizon NW may re-file the residential Late Payment Charge tariff provision or file a modified tariff for continued operation of the residential Late Payment Charge at any time after July 1, 2007. Verizon NW does so with this filing by making three deletions to provisions within the tariff that describe expiration of the residential Late Payment Charge on December 31, 2007.

Recognizing that the commission will likely prefer to review Verizon NW's final report on implementation of the residential Late Payment Charge, which is due to be filed on August 15, 2007, before removing the expiration provisions, the enclosed tariff deletions are effective on September 13, 2007. Additionally, in order to facilitate commission review of the report to be delivered on August 15, 2007, Verizon NW encloses a preliminary report with this Advice Letter ("Preliminary Report"). The Preliminary Report includes data through May 31, 2007, as well as a narrative explaining the results. Thus, the only new information to be provided in the August report (which, per paragraph 30 of Order No. 15 in Docket No. UT-040788, is to address the first six months of 2007) will be data from June 2007. The data in the Preliminary Report continues the significant trend shown in previous reports of declining revenues from the Late Payment Charge, as well as reductions in the numbers and percentage of customers assessed the charge (including reductions among customers eligible for the Washington Telephone Assistance Program). That trend, as well as the absence of any impact by residential Late Payment Charge on the number of disconnections, should assuage the commission's stated reasons for reviewing the impact of implementation of the residential Late Payment Charge (see paragraph 28 of Order No. 15 in Docket No. UT-040788).
