Welcome to Collo Classifieds! This website allows you to view lists of returned collocation sites that are available for acquisition. In addition, if you currently have a collocation site that you wish to make available for another CLEC to assume through Collocation Transfer of Responsibility, you can input all of the site specifications and "advertise" it here.

All collocation sites posted on Collo Classifieds fall into one of the following categories:

- 1) Active/Complete Sites (Potential for Transfer of Responsibility)
- 2) Cancelled Sites
- 3) Decommissioned Sites
- 4) Abandoned Sites
- 5) Sites available due to legal proceedings

If you are a CLEC who wishes to acquire a CLEC posted site, contact the party listed on the spreadsheet and follow the ordering procedures described within the Collocation Transfer of Responsibility product offering. If you wish to acquire a Qwest posted site, follow the ordering procedures described within Collocation Available Inventory.

If you would like the entry to remain on the spreadsheet after day 90, you must resubmit the information on this form.
