# BACKGROUND

- On December 2, 2002, Bremerton-Kitsap Airporter, Inc., C-903 (Bremerton-Kitsap Company) filed with the Commission revisions to its currently effective Tariff No. 7, designated as Tariff No. 8, containing fare increases for passengers.
- 2 On December 31, 2002, the Commission entered a Complaint and Order Suspending Tariff Revisions pending an investigation to determine whether the revisions were fair, just and reasonable.
- 3 On March 4, 2003, the Commission received a request from Bremerton-Kitsap to withdraw its tariff filed in Docket TC-021578.

## FINDINGS AND CONCLUSIONS

4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate rates, rules, regulations, practices, accounts, securities, and transfers of public service companies, including auto transportation companies. *RCW 80.01.040; Chapter 81.01 RCW; Chapter 81.04 RCW; Chapter 81.28 RCW and Chapter 81.68 RCW*.

- 5 (2) Bremerton-Kitsap is an auto transportation company and is a public service company subject to the jurisdiction of the Commission.
- 6 (3) This matter was brought before the Commission at its regularly scheduled meeting on March 12, 2003.
- 7 (4) Bremerton-Kitsap asked to withdraw the tariff revision(s) presently under suspension in Docket TC-021578.
- 8 (5) After review of the tariff revision(s) filed in Docket TC-021578 by Bremerton-Kitsap, and giving due consideration, the Commission finds it is consistent with the public interest that the Complaint in Docket TC-021578, dated December 31, 2002, be dismissed, and the Company be allowed to withdraw the filing.

## O R D E R

## THE COMMISSION ORDERS:

- 9 (1) The Complaint and Order suspending Tariff Revisions(s) in Docket TC-021578, dated December 31, 2002, is dismissed.
- 10 (2) The tariff filing is withdrawn and Docket TC-021578 is closed.
- 11 The Commissioners, having determined this matter to be consistent with the public interest, directed the Secretary to enter this Order.
