Washington Moving & Storage, Inc.

On January 31, 2006, the commission issued a Notice of Penalties to Washington Moving & Storage, Inc. (Washington Moving) in the amount of \$100 for a violation of WAC 480-15-480. WAC 480-15-480 requires household goods carriers to file annual reports with the commission no later than May 1 of each year. The company did not respond to the Notice of Penalties within 15 days. Staff sent a letter signed by Carole Washburn on April 24, 2006, stating that if payment was not received by May 10, 2006, the commission would consider additional sanctions and the matter would be referred to the Office of the Attorney General. The company did not respond.

On May 2, 2006, Washington Moving requested the commission cancel its household goods permit number HG-19148. The company's permit was canceled on May 3, 2006. Based on this information, we are requesting authority to write off the \$100 penalty assessed against Washington Moving.
