On April 27, 2006 PacifiCorp filed original Advice No. 06-002 requesting an increase in revenues from Washington operations not to exceed 2.99 percent for each customer class, or \$7.009 million to become effective May 27, 2006. Concurrently, the company submitted a motion in the Consolidated Dockets to further consolidate the docket established for this Application with consolidated Docket Nos. UE-050684 and UE-050412.

Since this filing, the Company has had the opportunity to explore with key parties whether an opportunity exists to convene settlement discussions to consider potential agreement among the parties. Several parties participating in these dockets have indicated a willingness to meet with the Company in an attempt to resolve the outstanding issues. In order to provide time for parties to have discussions and to link the timing of the decision on this filing with the expected timing of the Commission's decision on reconsideration, the company proposes to change the requested effective date for proposed Schedule 193 to July 1, 2006. Furthermore, the Company is not opposed to the Commission extending the time for ruling on the Petition for Reconsideration for a similar period, i.e., to no later than July 1, 2006. In recognition of these changes, the Company respectfully requests that the Commission remove this item from consideration at its May 17, 2006 Open Meeting.


