3. The temporary .50% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of February 2007 and March 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of May and June 2007.

Customers who are billed bi-monthly for services – one month in arrears and the current month:

The surcharge will appear on the June 1, 2007, billing and applies to all services provided in the months of May 2007, and June 2007.
