**PLEADING CYCLE ESTABLISHED FOR COMMENTS  
ON QWEST'S PETITIONS FOR FORBEARANCE IN THE  
DENVER, MINNEAPOLIS-ST. PAUL, PHOENIX, AND SEATTLE  
METROPOLITAN STATISTICAL AREAS**

**Comments Due: July 17, 2007**  
**Reply Comments Due: August 16, 2007**

On April 27, 2007, Qwest Corporation (Qwest) filed four separate petitions pursuant to section 10 of the Communications Act of 1934, as amended (the Act),<sup>1</sup> requesting that the Commission forbear from applying to Qwest certain obligations in the Denver, Minneapolis-St. Paul, Phoenix, and Seattle Metropolitan Statistical Areas (MSAs).<sup>2</sup> Specifically, according to its Petitions, Qwest seeks forbearance from loop and transport unbundling obligations pursuant to sections 251(c) and 271(c)(2)(B)(ii) of the Act, and section 51.319(a), (b), (e) of the Commission's rules.<sup>3</sup> For mass market and enterprise services, Qwest also seeks forbearance from Part 61 dominant carrier tariffing requirements (47 C.F.R. §§ 61.32, 61.33, 61.38, 61.58, 61.59); Part 61 price cap regulation (47 C.F.R. §§ 61.41-61.49); *Computer III* requirements, including CEI and ONA requirements; and dominant carrier requirements arising under section 214 of the Act and Part 63 of the Commission's rules concerning the processes for acquiring lines, discontinuing services, assignment or transfers of control, and acquiring affiliations (47 C.F.R.

§§ 63.03, 63.04, 63.60-63.66).<sup>4</sup> Qwest claims that multiple competitive alternatives are available to mass market and enterprise customers alike, including wireline and cable-based services. Qwest adds that intermodal competitive competition, particularly from wireless and voice over Internet Protocol (VoIP) providers is more advanced than it was in the Omaha MSA in 2005, when the Commission adopted the *Omaha Order*.<sup>5</sup>

This Public Notice establishes certain procedural requirements relating to consideration of the Qwest Petitions. This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission’s rules, 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.45 and 1.419 of the Commission’s rules, 47 C.F.R. §§ 1.45, 1.419, interested parties may file comments on the Qwest Petitions for forbearance on or before July 17, 2007 and reply comments on or before August 16, 2007.
