The company requests Commission approval to amend its filed Tariff Number 10 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$1.927 per gallon for the base period (12 months ended December 31, 2004) to \$3.394 per gallon current price.

1. The Commission finds good cause to support the request and authorizes the proposed changes to become effective with Less Than Statutory Notice on: January 1, 2008.
2. The proposed changes will expire on: March 31, 2008.
3. The temporary 1.48% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of September, October and November 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of January, February and March 2008.

Customers who are billed quarterly for services – one month in arrears and two months in advance:

February 2008 /	February, March and April 2008
March 2008 /	March, April and May 2008
