1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: May 1, 2008.
2. The proposed changes will expire on: June 30, 2008.
3. The temporary 2.60% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of February 2008 and March 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of May 2008 and June 2008.

Customers who are billed bi-monthly for services – one month in arrears and the current month:

The surcharge will appear on the June 1, 2008, billing and applies to all services provided in the months of May 2008, and June 2008.
