The company requests Commission approval to amend its filed Tariff Number 16 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement #2 to recover the rising cost of fuel. Fuel index prices have increased from \$2.018 per gallon for the base period (12 months ended March 31, 2005) to \$3.439 per gallon current price.

Proposed changes are to add a Special Fuel Surcharge in the amount of: 0.98%


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of May, June and July 2008.
