The company requests Commission approval to amend its filed Tariff Number 10 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$1.9274 per gallon for the base period to \$2.7570 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 14 in the amount of 1.46%.


For customers who are billed monthly for services in the current month, the fuel surcharge applies to all services provided in the months of March 2010 and April 2010.
