3. The temporary 1.62% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of August 2010 and September 2010, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November 2010 and December 2010.
