The company requests Commission approval to amend its filed Tariff Number 25 on Less Than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.4910 per gallon for the base period to \$3.7415 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 18 in the amount of 1.34%.
