Subject: TR-111649 Port of Chehalis
Grade Crossing Protective Fund (GCPF) Project to install approximately
29 "No Trespassing" signs along the Curtis Rail Line

On October 13, 2011, the Washington Utilities and Transportation Commission (Commission) awarded a GCPF grant totaling \$818.09 to install approximately 29 "No Trespassing" signs along the Curtis Rail Line. The Curtis Rail Line is 10 miles in length and the Port is replacing signage at 11 trestles and seven highway rail grade crossings. Previous signage was damaged by floods or vandalized.

On March 30, 2012, the applicant, the Port of Chehalis submitted a request for reimbursement pursuant to Commission order. On March 28, 2012, Commission staff conducted a site visit and verified that the project was completed according to the specifications outlined in the order approving the grant.
