Fuel index prices have increased from \$2.9480 per gallon for the base period to \$4.0470 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 8 in the amount of 1.43%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November 2011 and December 2011.
