**RE:** Docket No. UE-111860 (Advice No. 2011-22) - <u>Do Not Redocket</u> Substitute Tariff Filing - Filed Electronically Request to Withdraw a Portion of Filing

Dear Mr. Danner:

A small portion of the filing in Docket No. UE-111860 has been the subject of discussions between the Company, Commission staff and other parties. Specifically these discussions have involved deleting or modifying a proposed new schedule (schedule 292). In order to resolve concerns regarding the new schedule Puget Sound Energy, Inc. (the "Company") hereby submits in connection with Docket No. UE-111860 the following substitute tariff sheets to replace the tariff sheets filed on October 27, 2011, under the Company's Advice No. 2011-22. This substitute filing is pursuant to RCW 80.28.060 and Chapter 480-80 WAC and includes the following portion of the Company's WN U-60 tariff for electric service.

This substitution implements changes to address an issue in the wording of Schedule 292 about which Commission staff raised a concern and to correct a typographical error in Schedule 261. This substitution meets the requirements for substitute tariff filings as provided in WAC 480-80-111(1) (a) and (b).

The Company believes that the originally proposed new Schedule 292 should be further discussed along with the relationship of this proposed program to the targets filed by the Company in response to RCW 19.285 at a future proceeding. Rather than risk the continuation of conservation programs to all customers, the Company is submitting this substitute filing but is considering submitting the originally proposed new Schedule 292 in a separate filing.
