Fuel index prices have increased from \$2.4910 per gallon for the base period to \$3.8362 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 19 in the amount of 1.53%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of December 2011 and January 2012.
