Fuel index prices have increased from \$2.9480 per gallon for the base period to \$3.7695 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 10 in the amount of .82%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March 2012 and April 2012.
