Company proposes to change Tariff Number 25

The company requests Commission approval to amend its filed Tariff Number 25 on Less Than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.4910 per gallon for the base period to \$4.2221 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 22 in the amount of 2.27%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of June 2012 and July 2012.
