1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: June 1, 2013.
2. The proposed changes will expire on: August 31, 2013.
3. The temporary .51% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of March 2013 and April 2013, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of June 2013 and July 2013.

Customers who are billed bi-monthly for services – Current month and one month in advance:

July 2013	July 2013 and August 2013
