Attached you will find the above-referenced Tariff Sheets and the proposed tariff maps that would become part of the above-referenced Tariff Sheets. The reason for the addition of Sheet 21.1 is that formerly the two exchanges were depicted on the same map. This filing has a separate map for each exchange.

During the process of the Commission developing electronic maps for submission to the Federal Communications Commission pursuant to the FCC's establishment of procedures for such filings (See, Wireline Competition Bureau Announced Procedures and Deadlines for Submission of Study Area Boundaries, WC Docket Nos. 10-90, 05-337, Public Notice, DA 13-456 (Wireline Comp. Bur. rel. Mar. 18, 2013)), it was discovered that there was certain discrepancies in the existing exchange maps for Western Wahkiakum County Telephone Company d/b/a Wahkiakum West (Wahkiakum West).
