Puget Sound Energy, Inc. ("PSE") hereby submits in connection with Docket No. UG-141212 the following substitute tariff sheet to replace the tariff sheet accompanying the Company's May 30, 2014, filing which was submitted under PSE's Advice No. 2014-18. An informative update under this Advice Number was made on September 18, 2014, in accordance with the Commission Policy On Accelerated Replacement Of Pipeline Facilities With Elevated Risk (the "Policy Statement") in Docket No. UG-120715. This substitute filing is pursuant to RCW 80.28.060 and Chapter 480-80 WAC and includes the following portion of the Company's WN U-2 tariff for natural gas service.

The purpose of this filing is to update the rates based on actual expenditures from November 1, 2013, through September 30, 2014, plus estimated expenditures for October 2014 in accordance with the Policy Statement.

This substitution is provided for in paragraph 69 of the Policy Statement. The tariff sheet described herein reflects the original issue date of May 30, 2014, and the original effective date of November 1, 2014.

This CRM filing represents an increase of \$2,280,577 or an average increase of 0.24% for all of PSE's approximately 781,849 natural gas customers. The impact of this filing on the typical residential customer using 68 therms per month will be an increase of \$0.17 on the current monthly bill of \$77.29. PSE's customers are located in PSE's certificated areas in King, Kittitas, Snohomish, Pierce, Thurston and Lewis counties. On September 30, 2014, PSE published the notice to customers required by WAC 480-90-194 which informed customers of the impacts of the CRM filing and the PGA/PGA Deferral filings. This CRM update filing overall reflects a slight increase in the impacts resulting from the two

filings. After incorporating this CRM update, the combined increase from the CRM and PGA/PGA Deferral filings is an overall average increase of 2.65%. The total increase related to the CRM and PGA/PGA Deferral filings for the typical residential customer using 68 therms is \$1.78 which increases the typical monthly bill from \$77.29 to \$79.07
