This Agreement is hereby amended by replacing and adding terms, conditions, and rates as set forth in Attachment 1 and Table 1 to the Amendment.

The Amendment amends the Interconnection Agreement first accepted by the Commission on May 12, 2016 in WUTC Docket No. UT-160388. That Agreement was originally approved by the Commission on February 20, 2015 in WUTC Docket No. UT-150074 between Company A and Company C (Teleport Communications, LLC).

Company A represents that the Amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the Amendment, Company A believes that Company B agrees with these representations.
