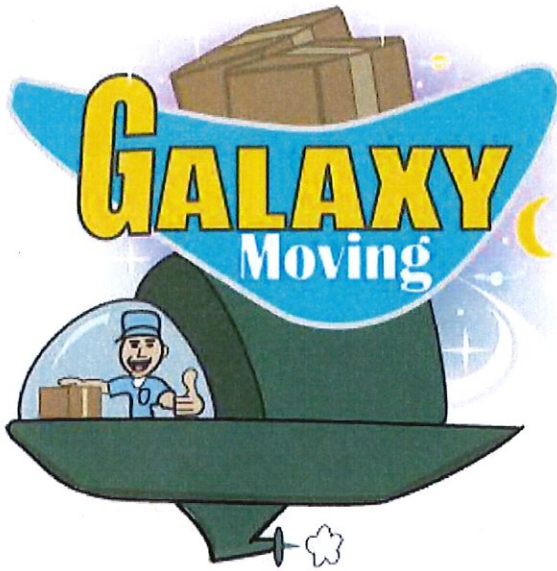

Received a flyer showing pricing. Based on having three guys, approx. 5-6 hours we were calculating the amount that would be owed at the end of the day.

The company used a sub-contractor and company name that we had never heard of. The bill was for EIGHT hours. When I asked him why the 8 hours, he replied that there was travel time of one hour each way. This was never discussed, not listed on the site, nor on the flyer. Furthermore, the office (if actually Galaxy) was a max of 30 minutes from us...not an hour on a Sunday!

The team was friendly and efficient so we paid them and would follow up with Galaxy the very next day. Zero response to our message, phone call, etc. VERY shady business practice. Like other clients, I should have read the reviews!!

Update-I was able to reach Richard at approx. 7:30 p.m. 9.27.17 and he seemed to be pro-active. He agreed that the travel time was about double of what it should have been! I sent him a screen shot of the invoice to which he replied that I would need to take it up with the SUBCONTRACTOR, HIS subcontractor. What a joke. His employee technically that we didn't know wouldn't be considered HIS employee. Nice!

Beware!!! Hire these guys at your own risk! We scheduled our move with them weeks in advance. We answered the usual questions about the number of rooms in our house, how many movers we wanted, etc. Originally, I thought we'd need 2 movers. Rich at Galaxy suggested 3 guys for a house our size, so I agreed that that probably made sense.

The day before our move, I called Rich to confirm we still had movers coming the following day. He seemed a little caught off guard, assured me that we still had guys coming, but mentioned that he thought he may have double booked us. It sounded like he'd forgotten about us. At any rate, he did confirm we'd have 3 guys out the following day around 9-10am. I let Rich know that with our house closing, we were on a strict timeline to get out on schedule.

Move day comes... About the time the guys should have been at or getting close to our house, I called Rich to see how far out they were. It was a little after 9am. I was told they were just getting the truck ready and heading right out. An hour later, at 11am, they showed up. It was 3 guys and a truck, as expected. We did a quick walkthrough of the house. Half of our stuff was already packed away in a storage unit, and we aren't hoarders, so there was just an average amount of furniture and boxes(which were already all packed and neatly stacked in the garage for quick transfer to the truck). At this point, they tell me this is too much work. They said it would be a 10-12 day for them, and they didn't want to do the job because they would have to do it all over again tomorrow(meaning that they had another move scheduled for the next day). They suggested coming back the next day with 6 guys to make it go faster. I let them know that waiting wasn't an option. We had to be out that day. I asked if they could please just begin work with the 3 of them, and just get as much out as they could by the end of the day. Still, the answer was no, and they just wanted to come back tomorrow with more guys. I called Rich at the office, and left him a voicemail, telling him the situation and that we needed to get the guys working right away. No response.

Meanwhile the guys are out on the phone, assumedly with Rich. When they got off the phone, one of the movers told me that one guy said if the office said they had to stay, he was going to have someone come pick him up. I made another call or 2 to Rich, with no answer. Eventually, the guys left, saying they'd be back to the next day with 6 guys. I had no option but to let them drive away, hours late to begin the move, zero work done, and now having to spend moving time looking for help instead.

I ended up getting a friend to leave work, hired 1 mover on short notice, and had another friend of a friend come help. I had to go out a get a rental truck, wasting a ton of time. We didn't actually get started moving anything until about 3pm. We worked our tails off and got everything moved and into the new house at 9:30pm. So 4 of us, (3 amateurs and 1 professional mover) completed in 6.5hrs, what the

"professional" Galaxy movers said would take them 10-12hrs.

Galaxy Moving really left us in a terrible spot. To this day, Rich has never called back. And the 6 guys that were supposedly coming back the next day never showed up.

Galaxy Moving has demonstrated to me that they are unreliable, unprofessional, and have no business taking on time sensitive projects. The scheduling was sloppy. The movers I met were unmotivated, and full of excuses. They showed up late, did nothing, and never made any effort whatsoever to correct them problem. I'm sure they're capable of doing a good job sometimes. But if you asked me for a mover you can count on, these guys would be at the bottom of the list.

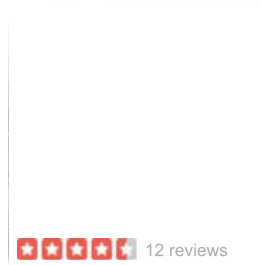
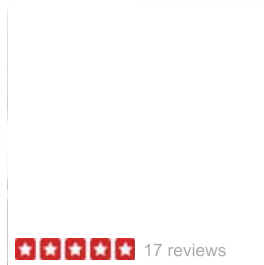
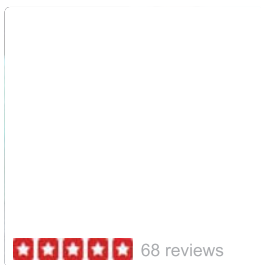

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by **Feb. 13, 2018**.

Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington State. Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**.¹ This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately cease advertising as a household goods mover in Washington State. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Galaxy Moving Company, LLC.
