NOTICE CANCELLING BRIEF ADJUDICATIVE PROCEEDING

and

**NOTICE REQUIRING STAFF TO FILE AN EVALUATION AND RESPONSE
(By Tuesday, August 6, 2019)**

TO ALL PARTIES:

On July 1, 2019, the Washington Utilities and Transportation Commission (Commission) issued a notice to Safe to Go Movers, LLC, (Safe to Go or Company) in Docket TV-190515 advising the Company that the Commission intends to cancel its household goods carrier permit effective August 13, 2019, unless Safe to Go obtains Commission approval of a safety management plan prior to that date (Notice). The Notice also set a brief adjudicative proceeding to hear this matter on August 1, 2019, at the Commission's headquarters in Lacey, Washington.

On July 9, 2019, the Commission issued a Penalty Assessment in Docket TV-190514 against Safe to Go in the amount of \$8,600 for the violations cited in the Notice. On July 24, 2019, the Company filed with the Commission a request for mitigation of the penalties, admitting the violations and requesting a hearing.

On July 30, 2019, Staff informed the presiding officer that the Company had submitted to Staff a proposed safety management plan. Staff evaluated the proposed plan and determined it is acceptable. Therefore, Staff recommends the Commission cancel the brief adjudicative proceeding and enter an order upgrading the Company's safety rating based on a paper record.

Staff also explained that it confirmed that the Company waives its right to a hearing in both dockets. Based on the parties' request to cancel the hearing, as well as Staff's approval of the

Company's safety management plan, the Commission finds good cause to cancel the brief adjudicative proceeding set for August 1, 2019, at 1:30 p.m. and will enter an order based on a paper record.

Staff must file in an evaluation of the Company's proposed safety management plan as well as a response to the Company's request for mitigation of the penalties assessed in Docket TV-190514 by 5 p.m. on August 6, 2019.

THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding in docket TV-190515 set for August 1, 2019, at 1:30 p.m. is cancelled. Commission Staff must file an evaluation of the Company's proposed safety management plan and respond to the Company's request for mitigation of the penalties assessed in Docket TV-190514 no later than 5 p.m. on August 6, 2019.
