GRANTING PETITION TO MODIFY  
ACTIVE WARNING DEVICES AT A  
PUBLIC HIGHWAY-RAIL GRADE  
CROSSING AT GUN CLUB ROAD  
AND AUTHORIZING EXPENDITURE  
FROM THE GRADE CROSSING  
PROTECTIVE FUND

**BACKGROUND**

- 1 On August 30, 2019, the Central Washington Railroad Company (CWRR or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission) a petition seeking approval to modify active warning devices at a highway-rail grade crossing (Petition). The Petitioner filed a revised petition on September 26, 2019. The crossing is identified as USDOT 098474H and is located at the intersection of Gun Club Road and the Petitioner's tracks in Yakima county, near the city of Yakima. The Petitioner further requests the Commission authorize an expenditure of \$10,106 from the Grade Crossing Protective Fund (GCPF) to pay for the modifications.
- 2 Gun Club Road is a three-lane roadway with a speed limit of 35 miles per hour. Estimated average annual daily vehicle traffic through the crossing is 2,026 vehicles. Gun Club Road is not part of an established truck route. Gun Club Road is part of an established school bus route with 20 school buses traveling over the crossing each school day. Two freight trains operate over this crossing daily at up to 20 miles per hour. No passenger trains operate over the crossing.
- 3 Railroad warning devices at the Gun Club Road crossing consist of gates, cantilever and mast-mounted incandescent flashing lights, bell, crossbucks, and constant-warning train detection. The Petitioner proposes to replace the existing incandescent warning lights at the crossing with 12" LED warning lights. The petitioner also proposes to replace and upgrade the existing 160 and 240 amp-hour batteries with new 264 and 368 amp-hour batteries.

4 The total amount requested for the upgraded LED lights and batteries is \$10,106. GCPF funds are available for this project. The Petitioner will provide the labor needed for installation.

5 Commission staff (Staff) has investigated the Petition and recommends that it be granted subject to the following conditions: (1) the modifications must conform to those described in and attached to the Petition, (2) traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation Manual on Uniform Traffic Control Devices, and (3) upon completion of the modifications authorized herein, the Petitioner must notify the Commission within 60 days. Acceptance of the changes is subject to inspection by Staff, who will verify that the crossing is in full compliance with applicable laws, regulations, and the conditions specified herein.

### **DISCUSSION**

6 RCW 81.53.261 requires that the Commission grant approval prior to modifying a public railroad-highway grade crossing within the state of Washington. RCW 81.53.271 authorizes the Commission to disburse funds from the GCPF to pay for improvements to highway-rail grade crossings. We find that the proposed modifications will improve overall safety for roadway users. Accordingly, the Commission grants the Petition subject to the conditions that Staff recommends.

### **FINDINGS AND CONCLUSIONS**

7 (1) The Commission is an agency of the State of Washington having jurisdiction over public highway-rail grade crossings within the state of Washington, and authority to approve and administer disbursements from the Grade Crossing Protective Fund.

8 (2) The grade crossing at Gun Club Road, identified as USDOT 098474H, is a public highway-rail grade crossing within the state of Washington.

9 (3) RCW 81.53.261 requires the Commission grant approval prior to any changes to public highway-rail grade crossings within the state of Washington. *See also* WAC 480-62-150.

10 (4) RCW 81.53.271 allows the Commission to disburse funds from the Grade Crossing Protective Fund to pay for the installation of a grade crossing protective device, without requiring the Petitioner to share the cost.

- 11 (5) Commission Staff investigated the Petition and recommends that it be granted subject to the conditions set out in paragraph 5 above.
- 12 (6) After reviewing the Petition filed by CWRR on August 30, 2019, and the revised petition filed on September 26, 2019, and giving due consideration to all relevant matters and for good cause shown, the Commission grants the Petition and request for disbursement of funds.

### ORDER

#### THE COMMISSION ORDERS:

- 13 The Central Washington Railroad Company's Petition to upgrade warning devices at a highway-rail grade crossing, located at Gun Club Road, is granted. The cost of the equipment for this upgrade shall be paid from the Grade Crossing Protective Fund. Approval of the petition is subject to the following conditions:
- (1) Expenditure from the Grade Crossing Protective Fund must not exceed \$10,106.
  - (2) Payment will be made upon presentation of claim for reimbursement for materials and verification by Commission Staff that the work has been satisfactorily completed.
  - (3) The Petitioner must sign and return the attached project agreement.
  - (4) The project must be completed no later than December 31, 2020.
  - (5) Traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*.
  - (6) The Petitioner must notify the Commission on completion of the upgrades authorized in this Order. Acceptance of the upgrades is subject to inspection by Commission Staff, and verification that the crossing is in full compliance with applicable laws, regulations, and the conditions specified in this Order.

*14* The Secretary of the Commission has delegated authority over this matter pursuant to Order 01 in Docket A-180762. The Secretary finds this Order to be consistent with the public interest.
