Dear Mr. Johnson,

Avista Corporation, dba Avista Utilities (Avista or the Company), submits this reply letter in response to the Washington Utilities and Transportation Commission's (WUTC) Notice of Penalties Incurred and Due for Violations of Laws and Rules (Notice) issued on March 18, 2021 in Docket D-200814.

The Company has reviewed the Notice, and while disappointed in the penalty assessed, accepts the penalty.

Included with this letter is a check in the amount of \$5,000 for the penalty assessment and locating certification records for ELM Locating and Utility Services (ELM) personnel involved in the violation. In lieu of the locator training, the WUTC pipeline safety staff informed the Company that they will accept Avista's Operator Qualification Locating Certification records which were completed on December 16, 2020. The locator that failed to accurately locate Avista's gas pipeline

facility, Jacob Edwards, resigned in May of 2020 so no longer works for ELM. Attached are the locating certification records for Tyler Proszek, ELM, Spokane Supervisor and Ryan Ross, ELM, Spokane Area Manager.

### WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION PENALTY ASSESSMENT D-200814, Investigation #8245
