- I On May 27, 2021, Neo Moving LLC (Neo Moving or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a household goods carrier in the state of Washington under Revised Code of Washington (RCW) 81.80 and Washington Administrative Code (WAC) 480-15.
- 2 On June 30, 2021, the Commission issued a Notice of Intent to Deny Application for Permanent Authority and Notice of Opportunity for Hearing in this matter based on its review and investigation of the application. The Commission alleges that the Applicant's owner, Charley Bowling, was convicted of Assault in the Fourth Degree in 2018. The Notice provided Neo Moving the opportunity to request a hearing to contest the factual allegations by July 9, 2021.
- 3 On July 2, 2021, Neo Moving filed with the Commission a Request for Hearing.
- 4 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Neo Moving's application for permanent authority should be denied due to the concerns raised after Staff's review and investigation of the application.
- 5 THE COMMISSION GIVES NOTICE That it will hold a virtual brief adjudicative proceeding in this matter at 9:30 a.m., on Wednesday, July 21, 2021.
