Puget Sound Energy (“PSE”) submits in connection with Docket UG-210434 the following tariff sheets to replace the sheets that accompanied PSE’s initial filing on June 9, 2021. This substitution filing includes the following portion of PSE’s WN U-2, Tariff for natural gas service:

6th Revision of Sheet No. 21-B - Rule No. 9 Bills and Payment for Service (Continued)
5th Revision of Sheet No. 21-C – Rule No. 9 Bills and Payment for Service (Continued)

On July 2, 2021, Governor Jay Inslee issued Proclamation 20-23.16, extending the utility shutoff moratorium through September 30, 2021. Previously, the utility shutoff moratorium under Proclamation 20-23.15 extended the utility shutoff moratorium through July 31, 2021.

The purpose of this substitute filing is to update the COVID-19 Pandemic Exception for reconnection charges and disconnect visit charges to state that the Company will suspend its collection of these charges until 180 days after the resumption date of disconnections allowed under Governor Jay Inslee’s Proclamation 20-23.16. Additionally, this filing corrects an error to the tariff symbols.

The tariff sheets described herein reflect an issue date of June 9, 2021, and effective date of July 31, 2021. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-90-193.
