PETITION FOR SUPPORT

COMES NOW Asotin Telephone Company d/b/a TDS Telecom, Lewis River Telephone Company, Inc. d/b/a TDS Telecom, and McDaniel Telephone Company d/b/a TDS Telecom (collectively, the "Companies") and, pursuant to Chapter 480-123 of the Washington Administrative Code ("WAC"), including, but not limited to, WAC 480-123-110, hereby petition the Washington Utilities and Transportation Commission (the "Commission") to receive support from the Universal Service Communications Program (the "Program") for the Program year 2022.

**I. Demonstration of Eligibility under WAC 480-123-100**

- 1 1. WAC 480-123-100(1)(a): Each of the Companies is a local exchange company as defined  
2 in WAC 480-120-021 that serve fewer than forty thousand access lines within the state.
- 3 2. WAC 480-123-100(1)(b): Each of the Companies is an incumbent local exchange carrier as  
4 defined in 47 U.S.C. Sec. 251(h).
- 5 3. WAC 480-123-100(1)(c): Each of the Companies offers basic residential and business  
6 exchange telecommunications services as set forth in WAC 480-120-021 and RCW  
7 80.36.630.
- 8 4. WAC 480-123-100(1)(d): Each of the Companies has established a plan, as described in  
9 WAC 480-123-110, to provide, maintain, or enhance broadband service (See II.4, below).
- 10 5. WAC 480-123-100(1)(e): Each of the Companies has been designated by the Commission  
11 as an eligible telecommunications carrier ("ETC") for purposes of receiving federal  
12 universal services support pursuant to 47 C.F.R. Part 54 Subpart D - Universal Service  
13 Support for High Cost Areas, with respect to the service areas for which the Companies are  
14 seeking Program support.

16 **II. Demonstration of Eligibility under WAC 480-123-110**

- 17 1. WAC 480-123-110(1)(a): The names of the legal entities that provide communications  
18 services and are seeking Program support are as follows: Asotin Telephone Company d/b/a  
19 TDS Telecom ("Asotin"), Lewis River Telephone Company, Inc. d/b/a TDS Telecom  
20 ("Lewis River"), and McDaniel Telephone Company d/b/a TDS Telecom ("McDaniel").
- 21 2. WAC 480-123-110(1)(b): A corporate organization chart showing the relationship between  
22 each of the Companies and its affiliates as defined in RCW 80.16.010 is attached hereto as

7 McDaniel: Schedule 14, Original Sheets No. 150-152 of its tariff WN U-4.

8 4. WAC 480-123-110(1)(d): Each of the Companies' broadband plans to provide, maintain, or  
9 enhance broadband services in its service area is attached hereto as Exhibit 3.

10 5. WAC 480-123-110(1)(f): A sworn statement by a company officer certifying that each of  
11 the Companies complies with state and federal accounting, cost allocation, and cost  
12 adjustment rules pertaining to incumbent local exchange carriers is attached as Exhibit 4.

13 6. WAC 480-123-110(1)(g): The number of residential and business local exchange access  
14 lines, broadband connections, unbundled monthly recurring rates for voice and broadband  
15 services as of December 31, 2020, and as of December 31, 2019 are included in the attached  
16 Exhibit 5. (The Companies have other business local exchange service rates, but they  
17 understand that WAC 480-123-110(1)(g) is requesting the single line business local  
18 exchange access service rate.)

19 7. WAC 480-123-110(1)(h): The requested statements relating to continued operations are  
20 attached as Exhibit 6.

21 8. WAC 480-123-110(1)(h)(i): A sworn statement by a company officer certifying that each of  
22 the Companies is in compliance with the Federal Communications Commission's obligation
