3. The temporary 2.29% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of March 2022 and April 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of June 2022 and July 2022.

Customers who are billed bi-monthly for services – current month and one month in advance:

August 1, 2022	July 1, 2022 – August 31, 2022
