1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: November 1, 2022.
2. The proposed changes will expire on: January 31, 2023
3. The temporary 3.74% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July, August, and September 2022, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November 2022, December 2022 and January 2023.

Customers who are billed quarterly for services – current month and two months in advance:
