- 1 On July 1, 2022, Accurate NW Moves LLC (Accurate NW) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a household goods carrier in the state of Washington (Application). The Application lists Andrew Gibbs as Accurate NW's owner.
- 2 On February 17, 2023, the Commission issued a Notice of Intent to Deny Application for Permanent Authority and Notice of Opportunity for Hearing (Notice) in this matter based on its review and investigation of the Application. The Commission alleges that the Applicant's owner, Andrew Gibbs, has a criminal history including five felony convictions in the past 10 years. The Notice provided Accurate NW the opportunity to request a hearing to contest the factual allegations by March 6, 2023.
- 3 On February 20, 2023, Accurate NW filed with the Commission a Request for Hearing.
- 4 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Accurate NW's Application for permanent authority should be denied due to the concerns raised after Staff's review and investigation of the Application.
- 5 Due to internal scheduling issues, and with the agreement of the parties, the Commission finds there is good cause to hear this matter on shortened notice. *See* WAC 480-07-440(1)(a) and RCW 34.05.434.
- 6 **THE COMMISSION GIVES NOTICE That it will hold a virtual brief adjudicative proceeding in this matter at 10 a.m. on Wednesday, March 29, 2023. To attend via**

- 7 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 8 Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide at its offices in Olympia, Washington, copies of documents in the current record for use by the parties or others who may want to review them.
- 9 Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents **no later than 5 p.m. on Friday, March 24, 2023**, and email such documents to the presiding officer also by 5 p.m. on Friday, March 24, 2023.
- 10 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
