NOTICE OF OPPORTUNITY TO FILE WRITTEN OBJECTIONS (By Monday, October 23, 2023)

Re: Rulemaking to Amend Pipeline Safety Program Fee Calculation, Docket P-230583

TO ALL INTERESTED PERSONS:

On July 14, 2023, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser an Emergency Rulemaking Order (CR-103E) for publication at WSR 23-15-057. The CR-103E revised WAC 480-93-240(3)(a) on an emergency basis to strike the provision requiring that the Commission offset calculation of pipeline safety fee program fees with penalties collected pursuant to RCW 19.122.055. Also on July 14, 2023, the Commission filed with the Code Reviser an Expedited Rulemaking (CR-105) for publication at WSR 23-15-059 to permanently amend that provision of WAC 480-93-240, and served a notice on all potentially interested persons providing opportunity to object to the proposed rule amendments no later than September 18, 2023.

On August 23, 2023, the Commission filed a supplemental Expedited Rulemaking (Supplemental CR-105) to include an identical revision of WAC 480-75-240, relating to hazardous liquid pipelines. The Supplemental CR-105 will be published at WSR 23-17-XXX on September 6, 2023.

Due to the later publication date of the Supplemental CR-105, the Commission now extends the deadline to object to this expedited rulemaking to permanently amend WAC 480-93-240 and WAC 480-75-240 to October 23, 2023.

Comment submissions should include:

- The objecting party's name
- The title and date of the objections
