Dear Residential Customer,

This is to notify you of a proposed rate change for residential customers in the Kent-Meridian Disposal Company areas of King County. Should the Washington Utilities and Transportation Commission (Commission) approve our request, customers will experience adjustments to all services provided by Kent-Meridian Disposal Company.

As you may know, it has been two years since our last general rate case. In that time Kent-Meridian Disposal Company has experienced changes in costs that are key to delivering our services including labor, fuel, and maintenance costs. In addition, the company continues to invest in new assets to ensure it can deliver the safest, most efficient service possible. **If approved, the proposed rates will become effective May 1, 2025**.
