Tariff No. 15: Customer Notifications

*** Present provisions are:**

45 day notice to customers for all tariff changes per RCW 81.28.050

*** Proposed changes are:**

Waive RCW 81.28.050 45-day requirement and allow customers to be notified on the first bill as stated in 480-70-271(2)(a)(ii).

*** Explain why the company is proposing this tariff revision:**

The tariff revision is for the increased WA B&O Tax rate from 1.75% to 2.1% effective October 1, 2025.

*** Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**

Historically, customers have been notified of these types of increases on their first bill, in accordance with WAC 480-70-271(2)(a)(ii). This approach helps minimize costs for ratepayers by avoiding unnecessary printing and postage expenses.
