Dear Residential Customer,

This is to notify you of a proposed rate change for residential customers in the Rabanco Ltd. dba Tri-County Disposal, Allied Waste Services of Klickitat County, Rabanco Recycling, areas of Klickitat County. Should the Washington Utilities and Transportation Commission (Commission) approve our request, customers will experience adjustments to all services provided by Tri-County Disposal as outlined in the table below.

As you may know, it has been over a year since our last general rate case. In that time, Tri-County Disposal has experienced increases in costs that are key to delivering our services including labor, fuel, and maintenance costs. In addition, the company continues to invest in new assets to ensure it can deliver the safest, most efficient service possible. **If approved, the proposed rates will become effective June 1, 2023**.
