
The following graph charts CenturyLink QC's access line counts in Washington.



The graphed data show that in the seventeen years between 2000 and 2017 the count of CenturyLink QC Washington access lines declined 80% from 2.418 million at the end of 2000 to 0.516 million at the end of 2017.

The last column of the table states annual Washington jurisdiction revenues inflation adjusted to 2017 dollars. It shows that in 2017 dollars, CenturyLink QC's 2017 annual Washington jurisdiction revenue is 19% of its year 2000 annual Washington jurisdiction revenue. Stated in 2017 dollars, the total decline between 2000 and 2017 in CenturyLink QC's annual intrastate revenue is \$1.215 billion, or 81%.
