Attached for your review and comment please find Field Change Request (FCR) Form #3 for the US Moorings Second Phase PDI. This FCR requests elimination of an accidental inclusion of bulk density analysis of surface and subsurface sediment in the Second Phase Pre-Design Investigation Quality Assurance Project Plan. This analysis has no identified remedial design data use and was not included in the Gasco Sediments Site and B1 Navigation Channel Project Areas. Please let us know if you have any questions during your review.

Please note that due to 1) limited recovery at some core locations and associated multiple collection attempts, 2) additional time attempting to collect cores that were obstructed by Advance American Construction (AAC) marine equipment, and 3) limited marine sampling contractor availability, we were unable to complete the second phase PDI. We will remobilize to complete sampling at the 6 remaining core locations, including one location that was continuously obstructed by the AAC equipment, when the marine contractor is available in the next few months. We will coordinate the sampling schedule with CDM Smith.
