2008 Annual Report

On January 22, 2007, the Commission issued Order No. 2, Order Accepting Settlement Agreement Subject to Conditions, in Docket U-061239. Paragraph 56 of the Order and paragraph 21 of the Settlement Agreement approved in the Order required PSE to file yearly report identifying all instances in which PSE released customer information to a third party for the purposes of marketing services or product offerings, including how written consent was obtained. The first report was filed on February 15, 2008 for calendar year 2007. This second report is required to be filed by February 15, 2009 addressing calendar year 2008.

1. Contractor Referral Service

Customers are sent bill inserts promoting various energy efficiency measures which may require a contractor for installation (such as weatherization and furnace rebates). The bill insert has a signature line giving PSE permission to provide one of our pre-screened contractors with the customer's name, address and phone number. A copy of the bill insert is attached. Once the customer signs and returns the form, PSE releases the customer information to the contractor. A similar form is used at home shows for customers that would like a contractor to contact them regarding installation of energy efficiency measures.

2. Business Energy Management

At the request of customers, PSE will release customer energy usage data to a designated third party for the purpose of assessing energy use or savings. A copy of the release form is attached.
