TO ALL PARTIES:

The Commission entered its Order No. 06 in these dockets on February 18, 2005. The Order, among other things, rejected a general rate proceeding tariff filed by Puget Sound Energy, Inc., on April 5, 2004, which was suspended by prior Commission order. The Commission's Order authorized and required the Company to file tariff sheets consistent with its terms. The Order also authorized the Commission's Executive Secretary to approve the authorized filing by letter if it complied with the terms of the Order.

On February 25, 2005, Puget Sound Energy, Inc., filed electric and gas tariff sheets as specified in the Order. A list of the tariff sheets is attached to this letter.

On March 1, 2005, the Commission served its Order No. 07 in these dockets granting in part and denying in part two motions for clarification, and denying a petition for reconsideration. On March 3, 2005, Puget Sound Energy, Inc., filed additional replacement tariff sheets to comply with the Commission's Orders. The Commission has examined the Company's filing, as amended, and it appears to comply with the terms of the Commission's Orders.

Therefore, pursuant to terms of the Orders, the tariff sheets indicated on the attachment to this letter will become effective as filed with an effective date of March 4, 2005.
