Enclosed for filing, in the above-referenced docket, please find the original and eighteen (18) copies of the revised confidential testimonies and exhibits for Public Counsel witnesses Stephen G. Hill and Donna M. Ramas, as well as a Certificate of Service. Please note that the testimonies have been revised to reflect corrections made due to the discovery of factual errors, as described below:

- Mr. Hill's revisions correct a data input mistake in the calculation of his recommended overall cost of capital. Previously, Mr. Hill incorrectly inserted the Company's recommended debt cost (5.8%) in his calculation, rather than the number included in Mr. Hill's direct testimony (5.19%).
- Ms. Ramas' revisions accomplish the following:
  - Incorporate the impact of Mr. Hill's revised calculations, as discussed above;
  - Correct Ms. Ramas' recommended pension adjustment to include the IBEW multi-employer pension plan amount into the total pension expense; and
  - Correct Ms. Ramas' summary schedule to reflect the Washington jurisdictional amount of depreciation expense to be removed as a part of her recommended reduction to plant additions.




