MEMORANDUM

- On February 15, 2006, Puget Sound Energy, Inc., (PSE) filed revisions to its currently effective Tariff WN U-60, Tariff G, Electric Service, Advice No. 2006-02, and revisions to its currently effective Tariff WN U-2, Gas Service, Advice No. 2006-03. PSE also submitted direct prefiled testimony and exhibits in support of its proposed tariff revisions.
- On April 3, 2006, PSE filed a Motion for Leave to File Revised Testimony and Exhibits as well as revised testimony and exhibits. PSE asserted that, subsequent to filing its testimony and exhibits, it discovered a number of minor, but substantive errors in certain testimony and exhibits. Specifically, two exhibits to the prefiled direct testimony of Janet K. Phelps contain calculation and methodological errors that result in inconsistencies in PSE's *pro forma* revenue calculations, rate spread, and rate design testimony. In addition, the balancing charge applicable to Schedule 57 transportation customers was erroneously applied to two contract customers.
- 3 PSE proposed to revise the following testimony:

- Prefiled Direct Testimony of Janet K. Phelps, (JKP-1T), at pages 29, 30, 36, and 37;
- Second Exhibit to the Prefiled Direct Testimony of Janet K. Phelps, (JKP-3), at page 2; and
- Sixth exhibit to the Prefiled Direct Testimony of Janet K. Phelps,(JK-7), at pages 1, 5, 6, and 7.
- The Commission's procedural rules require PSE to seek leave for filing the proposed revisions if they include substantive changes other than to simply correct errors of fact asserted by a witness. WAC 480-07-460(1))b)(ii).
- No other party to this proceeding opposed the motion.
- The Commission finds that good cause exists to grant PSE's unopposed motion for leave to file revised testimony and exhibits. Allowing the revisions will help ensure that and full and accurate record on which to base a decision is developed.

ORDER

THE COMMISSION ORDERS, that PSE's Motion for Leave to File Revised Testimony and Exhibits is granted.
